- The Boy Scout project that Zach Napora presented to the Board in April 2011 and again in March 2012, needed more information on the area that he would like to place it. In searching through the original Cemetery Association minutes, it was stated in the resolution of March 27, 1915, that the land marked out surrounding the soldiers monument, be for the purpose of military honors only and that no burials of any person shall be made upon such dedicated ground. Councilperson Ingalls met with Zach at the cemetery to mark out the area he would like to use. After the information was presented to the Board a motion was made by Councilperson Wittenburg, seconded by Councilperson Iantorno that the project presented by Zach Napora be approved with the understanding that the footer be done by Bill Griggs and that there will be no cost to the Town of Bolivar.
